The Luxembourg Centre for Contemporary and Digital History (C²DH), together with the European University Institute (Florence, Italy) and the Max Planck Institute for Legal History and Legal Theory (Frankfurt am Main, Germany), organises this Summer School to explore methods of oral history and to test digital tools, while it pays attention to how digital sources may shape narratives in contemporary European history.
